HAVING REGARD TO Rectoral Decree No 3592 of 25.03.2024 by which the Research Ethics Committee was set up for the three-year period 2024/2026 and at the same time Prof. Viola Schiaffonati was appointed as Chairperson of the Committee for the same period;
HAVING REGARD TO the note of 08.04.2024 in which Prof. Viola Schiaffonati appointed Prof. Gabriele Pasqui as Deputy Chairperson of the Research Ethics Committee for the three-year period 2024/2026;
HAVING RECOGNISED the need to take action;

HEREBY DECREES

Art. 1

For all the reasons expressed in the preamble, Prof. Gabriele Pasqui – Full Professor – belonging to the Department of Architecture and Urban Studies of Politecnico di Milano, is appointed Deputy Chairperson of the Research Ethics Committee of Politecnico di Milano for the three-year period 2024/2026.

Art. 2

The term of office of Prof. Gabriele Pasqui as Deputy Chairperson of the Research Ethics Committee of Politecnico di Milano shall commence on the date of registration of this measure and shall end on 31 December 2026.
